It's so much easier to sign off on a corporate works project that is pushed in front of you repeatedly by someone whose job it is to pester you into approval. Citizens don't have the luxury of time to apply such consistent pressure, yet our interests are (or *should be*) inherently more important than businesses.

 Bike lanes. Not one here and there but real additions to our roadways, stretching outward from the city center. You're almost literally pouring money at Route 29 and Pantops development, yet a tiny fraction of that money could be used to reduce the overall load across the entire town's road system. It would improve citizen health, protect cyclist commuters, create "small areas" as you call them, and promote alternate travel routes (further reducing stress on main traffic corridors). Studies repeatedly show these and other positive benefits for cities globally who have committed to investment in their citizens this way. I would personally commute from Milton if Rt 250 wasn't an absolute death zone with ZERO shoulder.

a. At first glance, how well do you feel that these focus areas reflect your goals for our community?

The goals are reasonable but in some ways too vague to effectively evaluate.

b. What feedback would you like to share about how these focus areas are ranked? We need to address the way we establish and grow our infrastructure and the built environment. There is a dichotomy between enriching the livability qualities within the growth areas and solidifying the environmental and agricultural productivity in the rural areas. We need to enhance, explore, improve and reassess this dichotomy. I would like to see the county initiate through its relationship with Senator Kaine, an amendment to the Federal Conservation Code, 170h. Currently the code provides federal and state tax incentives for the conservation/preservation of rural, historic and environmentally sensitive areas. The code structure facilitates a compromised approach to our built environment; there should be tax incentives similar to those currently in 170h for development within our built environment that may/should have commercial utility that provide superior environmental benefits to the community above and beyond those currently required by



code. The notion here is to find ways to incentive the development community to "front load" superior environmental, energy, agriculture and open space within our built environment: Gotham Greens (agricultural example), NASA's Ame's Sustainability Base, (energy and sustainable developmental modeling). Perhaps a third area to look intellectually may be to negotiate an amendment to the Biscuit Run State Park agreement that could be a focal point for the above along with the education thereof for the generations to come. This area was usurped from the county tax roll; we should find a way to effectively return that growth area property to the county's tax base while facilitating a unique opportunity for State and Albemarle County economic and environmental enhancement and growth.

I think that the focus areas fairly reflect my goals for the community. One exception is engaging the community. I think that the County does a great job of this already for the citizenry that has an active interest in community issues. I'm uncertain whether the rural areas and natural resources need to be separate. There is no "urban" area focus despite the fact that many of the areas address urban issues. I think a holistic approach might be more appropriate.

- b. What feedback would you like to share about how these focus areas are ranked? I think it would be interesting to take all of the priority rankings out of the categories and rank them on their own. For instance, the current configuration seems to indicate that LCAPP (Tier 2) is a larger priority than County Facility Needs (Tier 3). Is that what this is trying to say?
- c. What additional comments would you like to provide?

I'd like to see more focus on the County partnering with the City, VDOT, MPO, etc. Many of the issues can be better and more equitably solved through working together. Increased traffic is a major quality of life detractor and there are many areas with major traffic issues that will continue to get worse from population growth without continued improvements and monitoring. This is more of a concern than roadway aesthetics. Several large transportation projects have been completed within the last 3-5 years which seem to have done little else than incrementally improve congestion. I'm surprised that the only item listed for life-long learning is pre-school accessibility. Since the Schools System is such a large portion of the County budget it seems that some additional focus might be provided here that doesn't overlap with the School Board's functions. I don't see the Police Department having any major issues despite their specific mention in Tier 1 and 2 areas of focus on the list.

Top Priority (Tier One Immediate Priority): Police Department staffing at a ratio of 1.5 sworn officers per 1,000 County residents.

Next Priority (Tier One Immediate Priority): That the Board of Supervisors budget for and hire an attorney in FY2018 to sue for release from the Revenue-Sharing Agreement with the City of Charlottesville.

Next Priority (Tier Two Mid-Range Priority): School choice for all Albemarle students, regardless of residential address, on a school building space-available basis with family-provided transportation to the chosen school or to a transportation hub from which public school buses depart on regular routes to the chosen school.

Next Priority (Tier Two Mid-Range Priority): School year Sunday afternoon hours at all JMRL branch libraries in Albemarle County.

Next Priority (Tier Three Longer Term Priority): Roadways that are safe for cars, trucks, motorcycles, and bicycles.

However, I feel the focus areas do not adequately reflect the priority our community places on protection and stewardship of our natural resources. Specifically, the Natural Resources and Rural Areas goals each only include two priorities, and none of them is ranked as Tier One. Further, both of the Rural Areas priorities appear to be focused more on intensifying uses in the Rural Areas rather than protection. I'll include below some specific recommendations to help put more emphasis on these critical community values.

- b. What feedback would you like to share about how these focus areas are ranked? I would like to see the two priorities currently ranked as Tier Two in Natural Resources upgraded to Tier One priorities.
- c. What additional comments would you like to provide?

Please consider adding a new Tier 1 priority to the Rural Areas section about strengthening the ACE Program by establishing a dedicated funding source and identifying adequate staff resources to implement it. This is identified as a priority strategy in the Comp Plan.

The current Tier 1 priority in the Development Areas section to "[d]edicate transportation revenue sharing money to several identified major transportation initiatives" is too vague. I would like to see it clarified to apply to "major transportation initiatives identified and



prioritized in relevant master plans and small area plans" to ensure the projects selected have been properly vetted by the community.

Please consider adding a new priority to either the Rural Areas or Development Areas section to capture the Comprehensive Plan's strategy of providing ongoing education to the public on the relationship of density in the Development Areas and efforts to prevent sprawl.

Please add new priorities to the Natural Resources section that reflect a number of other priority strategies from the Comp Plan, including the development of an updated Biodiversity Action Plan, the development of a Community Resilience Plan, and the use of existing master plans to identify important streams and wetlands for protection. The Tier Two priority under the Critical Infrastructure goal that relates to broadband may need to be revised to reflect recent Board of Supervisors guidance to focus first on places within the development areas that do not have adequate broadband service (and for the initial focus in the Rural Areas to be limited to those communities where there's the most "bang for the buck").

At first glance I was struck by how little mention I noticed of environmental concerns. All of the other goals will not be sustainable if sufficient attention is not given to the environment. Environmentally related focus would include: adaptation to climate change (e.g. the current summer temperatures), ways to help reduce the causes of climate change, continuing to provide a safe and adequate water supply, and continued preservation of natural resources and viewsheds not just for aesthetics but also for economic and societal health.

Again, at first glance, the budget goals seemed to include repeated references to projects that are nearing completion (e.g., the Rio/Route 29 area). Perhaps careful rereading will change my understanding of the priorities but as I currently interpret the budget plan I am concerned that repetition will give some areas much more focus than others.

My community goal would be a more equitable distribution of financial resources among the social, environmental, and economic areas, not so much emphasis on spending money on economic development (which by no means guarantees more income to the county government).

b. What feedback would you like to share about how these focus areas are ranked? Regarding specific focus areas:

- •Under the "Successfully engage citizens so that local government reflects their values and aspirations" goal I would like to see a focus on "determining the effectiveness of methods currently in use" and give it a Tier Two ranking.
- •Under the "Preserve the character of rural life with thriving farms and forests, traditional crossroad communities, and protected scenic areas, historic sites, and biodiversity" goal I would put "Establish ..." into Tier One and "Assure ..." into Tier Two.
- •Under the "Prioritize, plan and invest in critical infrastructure that responds to past and future changes and improves the capacity to serve community needs" I would move "Develop differentiated funding strategies for core vs. enhanced (e.g., quality of life projects like parks, etc.) projects in the rural areas." All the budget prioritizing in the world is useless if there is no way to increase the county's income. Regarding the prioritization process:
- •It is difficult for us citizens who are not familiar enough with the budget and needs of the county to understand all of the reasons for ranking in a specific tier. I would have found it



helpful if the information were presented with flagging that indicated projects that are in Tier 1 because they are almost completed or because they will be getting funding from outside sources. Also, some of the focus areas seem to reflect potential actions or projects whereas others are more like overarching concepts (e.g. above mentioned "alternate, sustainable funding strategies" and "assess the County's future physical facility needs") or work expected to be part of the normal duties of county staff. Perhaps these should be listed as priorities but not tiered.

•I recommend comparing the areas of focus with the Indicators of Progress in the Comprehensive Plan. Ranking should also depend on how well an action will allow the county to meet the Indicators.

a. At first glance, how well do you feel that these focus areas reflect your goals for our community?

This is a good start though I think at times there is too much emphasis on making one size fit all. What is appropriate in one area may be woefully inappropriate in another area.

b. What feedback would you like to share about how these focus areas are ranked? If there is to be a best value obtained by local government for the taxpayer dollar then I suggest you elevate two of the Tier 3 statements to Tier 1. In particular, under Critical Infrastructure and Operational Capacity there are Tier 3 statements that address strategic planning. Placing them at Tier 3 tells me the BoS is not interested in starting with a plan, rather they would prefer to use a piecemeal approach that lacks vision. If there is no unified strategic vision that integrates the county, schools and CIP, then this process is a waste of time and money.

Given that about 55% of the county budget is tied to funding schools there must be a tight planning process rather than three processes operating independently which it seems has been the case for decades in Albemarle County. This will mean some people will have to give up some power and there will have to be compromise but that is what it will take if the county residents are to support increased taxes and bond initiatives. As an example, the voters will be asked to determine the fate of a school bond issue in the coming November election. From my viewpoint, there is no compelling case for this bond based on the lack of integrated planning and a track record of processes that are not in sync with one another.

c. What additional comments would you like to provide? I suggest that the concept of Urban Service Districts be approached very carefully. Don't be too quick to rush into higher taxed areas and thus establish areas people may avoid when considering their real estate options. To see how this works think about the real estate purchase choices people make when considering whether to live in Charlottesville city or to live in the county. Pretty high on the list of considerations is the tax rate. No surprise many

home buyers, myself included, look closely at where the city boundary is and then avoid it



like the plague.

Economic Prosperity - This Tier 1 element is inadequately focused. It is not enough to give attention to Rio/Route 29. The county needs to figure out how it can brings jobs to the county that are beyond the service industries (e.g. retail stores, restaurants, etc.). Service workers are not well compensated as a group and to live in this area requires more than what can be made working at a store or restaurant. Raising the minimum wage is not the answer since that just makes everything more expensive, the real answer is to foster jobs that bolster and expand what remains of the middle class. While Albemarle County is fortunate to have major employers such as UVA and NGIC to provide well paid jobs, these are typically not within reach of the average middle class person due to the requirements for advanced degrees or very specialized experience and high security clearance. Like it or not, to expand economic opportunity the county has to look at light industry which means establishing pad ready sites and an approval process that is viewed as being helpful rather than punitive.

I think the focus areas concentrate a lot of attention on the development areas while not giving adequate attention to the need to protect and preserve the Rural Areas.

b. What feedback would you like to share about how these focus areas are ranked?

In the Rural Areas focus area, I suggest adding a Tier One goal of protecting and preserving the rural areas, including funding for the ACE program. I also suggest adding a Tier One goal of educating the public about the need to support density in the development area in order to protect the rural areas from sprawl. In general, I think this focus area needs to include more specifics about how the county plans to "preserve the character of rural life with thriving farms and forests, traditional crossroad communities, and protected scenic areas, historic sites, and biodiversity."

In the Critical Infrastructure focus area, I suggest moving the Tier Two goal of establishing and implementing strategic direction to expand broadband affordable access to Tier One, and moving the Tier Three goal of establishing and implementing strategic direction for school space needs to Tier One.

In the Development Areas focus area, I suggest moving the Tier One goals of developing an approach to support small area planning and working with regional partnerships to enhance Rivanna river corridor to Tier Two. The Tier One goal of dedicating transportation revenue sharing money to several identified major transportation initiatives needs clarification; the priority should be on transportation projects outlined in the Master Plan and small area plans.

In the Economic Prosperity focus area, I suggest moving the Tier One goal to Tier Two. This focus area should mention the Target Industries Study and its possible implementation. In the Educational Opportunities focus area, there is no mention of plans to provide lifelong learning opportunities for post-grads and adults. This should be included.



In the Operational Capacity focus area, I suggest more specificity in the third goal of developing alternate, sustainable funding strategies since much of this research has already been done. I suggest moving the Tier Two goal to Tier One and the Tier Three goal to Tier Two.

In the Natural Resources focus area, I suggest moving the Tier Two and Tier Three goals to Tier One and adding goals of updating the Biodiversity Action Plan as well as plans to protect streams and wetlands.

- 3. Infrastructure: Working with VDOT could go beyond aesthetics to address engineering protocols that sacrifice pedestrian and bicycle access to car speed
