### MENTAL HEALTH CRISIS PUBLIC AWARENESS CAMPAIGN SUMMIT

20 - 22 OCTOBER, 2022 JAMES MADISON'S MONTPELIER GARRETT HALL, UNIVERSITY OF VIRGINIA



## PURPOSE

The Mental Health Crisis Public Awareness Campaign is a collaborative effort on the parts of the Public Engagement in Governance Looking, Listening and Learning Laboratory (PEGLLLLab) in the Frank Batten School of Leadership & Public Policy at the University of Virginia, in conjunction with the producers of the 2019 Emmy Award Winning HBO Documentary, Ernie & Joe: Crisis Cops. This campaign has four pilot sites: Athens, GA, Charlottesville, VA, New Orleans, LA, and Thomasville, GA.

Awareness of the mental health crisis and its complexity are central and imperative at the local, regional/statewide, and national levels. As a result, the goal of this campaign is: to create, leverage and catalyze a sense of shared responsibility on the parts of the public and their public servants across the pilot site communities to better understand and address the mental health crisis within a framework of community well-being. This approach is designed to align public expectations with policies, processes, practices, services, and programs of first responders and public serving governing institutions.

The objective of the campaign reflects a three-step process:

- Public awareness of the mental health crisis that impacts communities and those who serve communities.
- Public and practitioner participation to better understand the nuances of the mental health crisis.
- Public and practitioner engagement and collaborative action that results in a more caring and compassionate response to those who are members of our communities who are in crisis.

In essence, this process encourages and ushers each community from a position of apathy to public awareness, to public engagement and ultimately to compassionate and collaborative action.

The PEGLLLLab seeks to **engineer change** by expanding policymaking conversations to include not only those who create and administer policies, but **those who live them**. We partner with municipalities and organizations to **broaden the definition of public safety** and keep ourselves and our communities safe, whole and thriving.

### SYNOPSIS

The Mental Health Crisis Public Awareness Campaign Summit convened representatives from all four sites on October 20th through 22nd at Montpelier's Claude Moore Hall and in the Great Hall of the Garrett Building on the Grounds of the University of Virginia. Representatives from the pilot sites included recipients of services, hospitalists, mental/ behavioral health executives and practitioners, representatives from youth serving institutions and faith-based organizations, local and state officials/ policymakers, first responders (police/fire/EMS), and subject matter experts. Plenary sessions focused on the impact of the mental health crisis on the criminal legal system, housing, education, economic development, and related policies and practices. These sessions were coupled with a panel discussion of leading hospitalists and mental/behavioral health executives noting its effects on individuals, families, the healthcare system, and overall community wellbeing. The convening concluded with a half-day of scenario-based training to catalyze a more compassionate response to those in crisis and support those who serve those in crisis.

As a metaphorical summit, this convening aimed to provide an opportunity for participants to look back, look around, and to look ahead by appreciating the complexity and taking advantage of the opportunity to address the mental health crisis and stress the intentionality of doing so in an equitable way.

#### **Robert Gray**

Robert Gray is a visionary, businessman, brand strategist and social entrepreneur with a passion for criminal justice reform and economic empowerment. As a native of Albemarle County, VA who was born in Charlottesville, he was able to experience firsthand both the opportunities and gaps that existed for the communities that raised him. As a result, he fostered a strong determination to operationalize socio-economic mobility as a means for building generational wealth and knowledge, especially among marginalized communities. Gray, a first generation college graduate, holds a Bachelor's of Arts in Political Science with a concentration in Public Policy from Saint Augustine's University. He has served as an NAACP Moral Freedom Summer Organizer, a Pathway Coach with the City of Promise, CEO and Creative Director of Dreamin' Diamonds, LLC., and currently holds the role of Cofounder and Executive Director of the Uhuru Foundation. His lifelong mission is to educate and empower all people socially, politically, and economically.

### **Timothy J. Longo**

Timothy J. Longo Sr. was appointed the University of Virginia's associate vice president for safety and security and chief of police in November 2019. In this capacity, Longo oversees the UVA Police Department, the department of Emergency Management, Clery Act compliance and the Office of Youth Protection, threat assessment, and safety and security systems and technology. He brings more than 40 years of experience in law enforcement leadership and higher education to his role.





### Judge David R. Sweat

Judge Sweat practiced law in Athens from 1979 until he was elected to be Judge of Superior Courts of the Western Circuit (Clarke and Oconee Counties) in 2002. In 2008, he established a mental health accountability court which assists individuals with mental illness and/or substance abuse involved in the criminal justice system. In 2014, he became Chief Judge of the Western Judicial Circuit. In 2017, he retired from active service and assumed senior status. In addition to serving as a senior judge, Judge Sweat acts as an arbitrator, mediator, and special master. He serves as Chair of the Board of Advantage Behavioral Health Systems. Judge Sweat enjoys barbecuing and is a Kansas City Barbecue Society Certified Barbecue Judge.

#### **Gilbert Gonzales**

Gilbert Gonzales has more than 30 years of experience in the field of substance abuse and mental health, crisis prevention and in treatment provision as a clinician, university faculty, project/program director and policy advisor. He has been responsible for development of program and implementation for community wide jail diversion services. Mr. Gonzales is the first Director for Bexar County's new Mental Health Department. Gonzales has served as a member of the Federal Substance Abuse and Mental Health Services Administration's (SAMHSA) National Leadership Forum for Behavioral Health and Criminal Justice Services, the National Stepping Up Initiative, the White House Data Justice Initiative and is a past member of the Board of Directors for the National Association of Counties (NACo). He has also served as the Chair of the Justice Committee of the National Association of Community Behavioral Health Disabilities Directors.





#### **Heather Zelle**


Heather Zelle, J.D., Ph.D., is an Associate Professor of Research with the UVa Department of Public Health Sciences and the Associate Director of Mental Health Policy Research at the UVa Institute of Law, Psychiatry, and Public Policy. She holds a juris doctorate from Villanova University School of Law, and a doctorate in clinical psychology with a forensic concentration from Drexel University. She is licensed as an attorney in Pennsylvania (voluntary inactive status) and as a clinical psychologist in Virginia. Dr. Zelle's current policy and research work focus on the public mental health system and mental health policy in Virginia. Dr. Zelle co-chaired the Criminal Justice Diversion Expert Panel that provided expert assistance to state legislators on issues including funding, policy, and statutory amendments concerning the Sequential Intercept Model, Crisis Intervention Team Assessment Centers, behavioral health dockets, jail mental health care standards, and information sharing between law enforcement and behavioral health providers. Dr. Zelle's policy and research experience include work with Dr. Patty Griffin for the Philadelphia Department of Behavioral Health and Intellectual Disabilities Services, including CIT training for Philadelphia law enforcement, assessment of specialty courts, and Cross Systems Mapping activities.

#### Anna Mendez

Anna Mendez is currently the Executive Director of The Haven in Charlottesville, Virginia after serving as Executive Director of Partner for Mental Health for seven years. She serves on the Board of Mental Health America of Virginia and serves as MHAV's Director of Public Policy. From 2020-2021 she was a Fellow-in-Residence at the University of Virginia Equity Center where her research focused on the decriminalization of mental illness. She serves on the Board of the Charlottesville-Albemarle Therapeutic Docket, a jail diversion program for defendants with mental illness and was recently appointed to Virginia's Marcus Alert Implementation Team, a group of first responders and mental health professionals charged with developing a statewide non-police response system for 911 calls related to behavioral health crises. Ms. Mendez frequently serves as a consultant to state agencies on issues related to improving Virginia's mental health service system. She lives in rural eastern Albemarle County with her husband and their eight year old daughter and believes that Virginians deserve an anti-racist mental health service system that is easily accessible and provides the full continuum of evidence based and person centered care.

#### **Paul Taylor**

In 1994 Taylor Paul was sentenced to life plus 26 years in which he served 23 consecutive years before being granted parole in 2017. While on the inside Taylor Cofacilitated all of the Virginia Department of Corrections state mandated programs in the re-entry cognitive community for over five years. He also created his very own programs called S.A.N.I.T.Y (Standing Against Negative Influences Towards Youth) as well as (with Co-founder Jawad Abdu) RVA league for safer streets an unorthodox basketball league that on purpose targets & engage high crime areas of the city. The motto "NO WORKSHOP,NO JUMPSHOT" lets players know that workshops on conflict resolution, problem solving, & critical thinking before a ball is dribbled or a shot is made are mandatory! Taylor is also an advocate for Unitive Justice, Restorative Justice & Criminal Justice reform as well as strong community engagement, believing that "unconventional behaviorism is a cause for unconventional strategies." Mr. Taylor Cofacilitated courageous conversations for DCJS with five localities in Virginia between community and law enforcement for a period of one year before recently being employed by DCJS as a community based organizer. He's also a motivational speaker and equity advisor on race relations for WMRJ and advisor for Decarceration Fund with his brand Taylor Paul Taylor LLC.

### Dr. Dan Silk

Dr. Dan Silk is the chief of police for University of Georgia Police Department, and he has served in a variety of other roles in campus, municipal, and federal law enforcement over his 28-year career. Dan completed three degrees at UGA, and was a Fulbright Fellow at the Institute of Applied Social Studies at the University of Birmingham, UK, where his research focused on police-community outreach. Dan has a courtesy faculty appointment in UGA's Department of Political Science, and he teaches in UGA's Criminal Justice Studies Program. He has consulted or taught for a variety of governmental and non-governmental organizations in Europe, Africa, Asia and the Middle East, primarily focusing on projects connected to applications of community policing. Dan is married to Monira Silk, a local business owner in Athens, and they have two daughters, Miriam and Nadine.





### Thomas von Hemert

Thomas von Hemert is the CIT Coordinator for the Thomas Jefferson Area CIT (Crisis Intervention Team) for the last sixteen years, the largest CIT program in Virginia. Tom and his Team have trained over 2,500 First Responders (police officers, sheriff deputies, correctional officers, emergency dispatchers, magistrates, firefighters/medics, probation officers and prosecutors) in CIT. He trained and mentored the development of many new CIT programs throughout Virginia and the United States. Tom graduated from Boston University with a degree in Business Administration with a concentration in finance. Tom worked as a Research Assistant Intern in the House of Parliament in London, England. Tom has received the Virginia CIT Coordinator of the Year Award and the Virginia CIT Program of the Year Award. Tom was a guest speaker on the National Public Radio (NPR) Diane Rehm Show on the subject of mental illness and the criminal justice system. Currently Tom is the Vice President of the Virginia State CIT Coalition Board and Past President of CIT International.
