Mr. Henry stated that all RDOF areas are evaluated for equity, timing, education opportunities, passings, etc.

Mr. Walsh stated that all things being equal we want this area served first but we do not want to add any additional cost to providing service.

Mr. Jaquith noted that we should be aware that existing infrastructure may limit the ability to accelerate the construction. It would be nice to know what those limits are.

Mr. Walsh **moved** that the chair be authorized to sign a letter to encourage Firefly to accelerate the construction in the RDOR area in the northeast part of the County.

Mr. DeLoria stated that the there will be a new policy for virtual attendance for adoption in August.










VATI 2021 Original Application Project Areas


## VATI 21 Rescope Recommendation


# CenturyLink/Lumen update

Per Lumen, as of this time:


- Analysis of 72 cables completed; 67 cables to receive rehabilitation







## Fiber on our Distribution System






