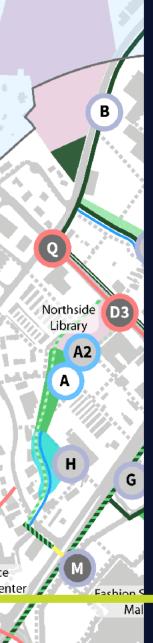


An application to develop one of the uses listed in the Albemarle County Zoning Ordinance as a "special use." A change in Zoning is not proposed.

Outdoor storage, display, sales in the Entrance Corridor

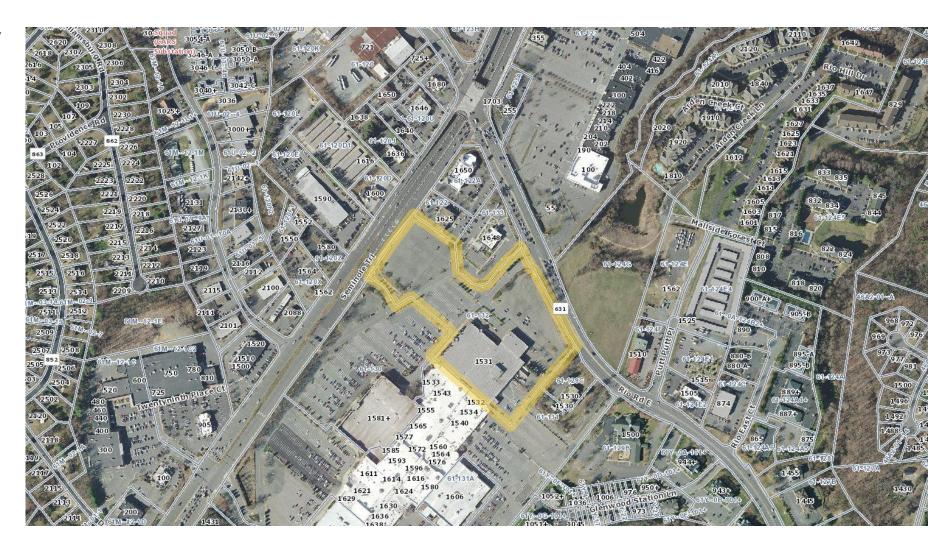

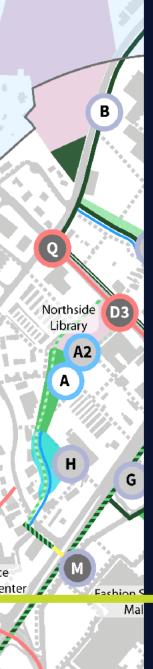
## special use permit (SP)

Sec. 30.6.3 - Permitted uses and applicable standards.









Within the EC overlay district:

- a. Uses. The following uses may be permitted within the EC overlay district in accordance with the applicable requirements of this section 30.6 and the underlying zoning district:
  - 1. By right. Uses permitted by right in the underlying zoning district shall be permitted by right in the EC overlay district, except as otherwise provided in section 30.6.
  - 2. By special use permit. The following uses shall be permitted by special use permit in the EC overlay district:
    - a. Uses authorized by special use permit in the underlying zoning district.
    - b. Outdoor storage, display and/or sales serving or associated with a permitted use, other than a residential, agricultural or forestal use, any portion of which would be visible from the EC street to which it is contiguous or from any other EC street which is located within 500 feet; provided that review shall be limited to determining whether the outdoor storage, display and/or sales is consistent with the applicable design guidelines. (Amended 9-9-92)
    - c. The construction or location of any structure, including any subdivision sign or sign identifying a planned development as provided in <u>section 4.15.16(I)</u>, upon the superjacent and subjacent airspace of an EC street that is not required for the purpose of travel or other public use by the Commonwealth of Virginia or other political jurisdiction owning such street.
