#### 1. Call to Order

A quorum of six was present at 4:45 p.m. when Mr. Fennell called the meeting to order.

### 2. Other Matters Not Listed on the Agenda

No public comments were made.

#### 3. ACEA202300004 Hirsh-Putnam Donation Proposal

Mr. Fulcher presented a proposal for a new donated easement on a 69.53-acre property owned by Robert Putnam and Christine Hirsh (Tax Map 114 Parcels 57, 57C, 57D).

Dr. Moses moved and Mr. Taylor seconded that the Authority accept the proposed easement, with the removal of the proposed terms regarding material timber harvest, and authorize the Chair to sign a deed containing the proposed terms. The motion passed by a vote of 6:0. Ms. Buttrick had temporarily left the meeting and did not vote.

## 4. ACEA202300009 Castlewood Farm Donation Proposal

Mr. Fulcher presented a proposal for a new donated easement on a xx-acre property owned by Castlewood Farm LLC (Tax Map 71 Parcel 38).

Dr. Moses moved and Mr. Taylor seconded that the Authority accept the proposed easement, with the addition of specific upper size limits for the permitted dwellings (4,500 square feet for dwelling 1; 1,500 square feet for dwelling 2; and 3,500 square feet for dwelling 3. The motion passed by a vote of 7:0.

The Chair invited old business. There being none, the meeting moved to the next item.
