Agenda Item No. 7a VATI 2021 Update

Mr. Inofuentes shared a PowerPoint presentation. (Attached to these minutes)

Mr. Henry asked why a nondisclosure agreement was needed.

Mr. Inofuentes stated that it is needed because Brightspeed will be providing detailed infrastructure information.

Mr. Andrews stated that ABBA needs to be able to sort between the NDA and implementing a solution.

Mr. Richey stated that an NDA will allow Mr. Culp and Mr. Inofuentes to meet with a variety of people and organizations such as ABBA and the Thomas Jefferson Planning District Commission to develop solutions and identify how and where improvements can be made.

Mr. Richard Schollman from Brightspeed announced that he will be leaving Brightspeed for a couple of months and that a new contact will be brought up to speed to work with ABBA.

Mr. Jaquith asked what progress has been made towards addressing installation problems.

Mr. Schollman stated that work is in progress, but no new information is available.

Agenda Item No. 7b VATI 2022 Update

Mr. Inofuentes shared a PowerPoint presentation. (Attached to these minutes)

Mr. Inofuentes stated that there have been no changes from last month. Mr. Inofuentes noted that Mr. Culp met with Beaver Dam Road residents to discuss why that area was not included in prior applications.

Mr. Gary Wood from Central Virginia Electric Cooperative stated that FireFly is working to bring fiber to that area.

Agenda Item No. 7c BAAO Update

i. DHCD BEAD Listening Session Report

Mr. Inofuentes shared a PowerPoint presentation. (Attached to these minutes)

Mr. Inofuentes stated that the amount of BEAD funding is unknown and that the FCC has not released mapping. Mr. Inofuentes noted that the 25% match in funding is preferred to be from the internet service provider and not from other entities.

Mr. Inofuentes noted that VATI 2024 is geared towards public private partnerships and smaller ISPs and BEAD is geared towards larger ISPs. DHCD will be looking at the FCC mapping to get an idea of what the unserved need is and where it is. This will determine the funding request.

Mr. Inofuentes stated that funding for non-deployment uses will be available in years 2-5. What qualifies has not been determined.

Ms. Price stated that as ABBA determines what coverage exists and is proposed thru VATI/RISE the smaller areas that are left will require ABBA to reach out to providers to encourage them to submit for coverage and that if no ISP responds the options to provide coverage are limited.

Mr. Jaquith noted that ABBA can still work with DHCD and use the VATI process. Mr. Jaquith stated that the remaining areas will be limited and scattered. These areas are likely to be adjacent to areas covered by other projects. The threshold to determine what is a high-cost area has not been determined. This may give options for alternative technologies such as fixed wireless. The high-cost threshold may be around \$20K per passing.

Mr. Henry asked for examples of non-deployment uses.

Mr. Inofuentes stated that if may include affordability programs, device distribution and digital literacy training.

Mr. Henry asked if ABBA could get a baseline of where we are in implementing VATI and other programs to get an idea of what is remaining.

Approved Minutes

Mr. Inofuentes stated that BAAO office is working on this.

ii. VACo, VML, and Broadband Association of Virginia Conference Report

Mr. Culp shared a PowerPoint presentation. (Attached to these minutes).

Mr. Culp stated that Virginia is ahead of other states.

Mr. Culp noted that Albemarle has multiple providers which will hopefully lead to competition.

iii. RDEP and ACP Outreach

Mr. Inofuentes shared a PowerPoint presentation. (Attached to these minutes).

Mr. Inofuentes stated that the demand for devices is high. Mr. Inofuentes noted that some people have expressed fear regarding the risks associated with connectivity.

Mr. Inofuentes shared a PowerPoint presentation. (Attached to these minutes).

Mr. Inofuentes stated that BAAO is working with FireFly to use about \$2 million in remaining ARPA funds to construct as much as possible.

Mr. Inofuentes stated that he was working with DHCD to determine how the scoring went.

Mr. Andrews asked if speeds were considered and will that change in the future.

Mr. Inofuentes stated that is expected that everything that was eligible in 2023 will be eligible in 2024.

Mr. Henry noted that we didn't get the award for 2023 and BAAO was looking at VATI 2022 and the possibility of changing the scope of that project using our remaining ARPA fund. What is left unserved will then be included in the 2024 request.

Mr. Walsh thanked Mr. Jaquith for running the meeting.






VATI 2021 Update

- Once the information is made available, BAAO will prepare an analysis of the areas that remain to be constructed which will be shared with ABBA and DHCD.




VATI 2021 Update – After Construction Completion

- A new tracking document has been opened to keep abreast of these issues







Orders by Project Area







