1. Call to Order

A quorum of five was present at 4:52 p.m. when Mr. Fennell called the meeting to order.

2. Approval of Minutes

Mr. Taylor moved and Ms. Emery seconded that the Authority approve the minutes of the May 11, 2023 and July 13, 2023 meetings.

The motion passed by a vote of 4:0, with one abstention.

Ms. Buttrick arrived.

3. Other Matters Not Listed on the Agenda

No public comments were made.

4. ACEA202300003 Logan Donation Proposal

Mr. Fulcher presented a proposal for a new donated easement on a 46.24-acre property owned by the Mark B. Logan Trust (Tax Map 29 Parcel 15C).

Dr. Moses arrived.

Ms. Buttrick moved and Mr. Moore seconded that the Authority amend the proposal to remove the term "substantially" from the proposed dwelling-location restrictions.

The motion passed by a vote of 7:0.

Mr. Taylor moved and Mr. Moore seconded that the Authority accept the amended proposal, and authorize the Chair to sign a deed containing the proposed terms.

The motion passed by a vote of 7:0.

5. ACEA202300009 Birdsall Donation Proposal

Mr. Fulcher presented a proposal for a new donated easement on a 2-acre property owned by the John H Birdsall III Trust (Tax Map 43 Parcel 44A). Ms. Buttrick recused herself from discussion of this item.

Dr. Moses moved and Ms. Emery seconded that the Authority accept the proposed easement.

The motion passed by a vote of 6:0, with Ms. Buttrick abstaining.

6. Funding Allocation Request – Field Monitoring

Mr. Clark presented a resolution prepared by Mr. Deloria that would appropriate \$50,000 from the Authority's unrestricted fund, for the purposes of reimbursing the County for the services of a part-time employee for field monitoring.

Dr. Moses moved and Mr. Taylor seconded that the Authority approve the resolution.

The motion passed unanimously.

5. New Business

The Chair invited new business. There being none, the meeting moved to the next item.

6. Old Business

The Chair invited old business. There being none, the meeting moved to the next item.

7. Adjournment

The Authority adjourned the meeting at 6:12 p.m.
