MAGISTERIAL DISTRICT: Samuel Miller TAX MAP/PARCEL: 07600-00-00-02400

LOCATION: 400 Stribling Ave Ext. just past the existing Nob Hill neighborhood. Property is along Sunset Ave. Ext and abuts I-64. The proposed development is across from the Jefferson Ridge and Eagles Landing apartment homes.

PETITION: Rezone 68.96 acres from R-1 Residential which allows residential uses up to 1 dwelling unit per acre to Planned Residential Development (PRD). The proposal is for 200 units, a mixture of single family detached and single family attached housing units, at a net density of 6 dwelling units per acre or a gross density of 2.90 dwelling units per acre. The proposal also includes 25% of the site as open space and land to be dedicated to public use for a greenway trail.
