Allie: After introductions, begins the meeting.

Brian Day presents motion to approve May 2019 CCAC minutes. Katya Spicuzza seconds the motion; all CCAC members present vote for approval. May 2019 CCAC minutes approved.

Kelly Gobble resigned from CCAC; need two resignations to have new members assigned, nominated so no new members at this time.

#### JAUNT:

- Introductions
- Stephen Johnson (update on Crozet Connect)
  - o Transit Pioneer test out the routes; incorporate into schedule based upon feedback
  - o Jaunt site: Find Your Connection.org about routes, process
  - o Crozet connect packet on ridejaunt.org; start with two routes west and east side of Crozet; two bus operate concurrently; 40 min departures offset; packet has possible stop locations
  - o Some shelters, but not in some areas; work with Old Trail
  - o Rider-business relationships
  - o Confirm Crozet two dollars one-way

  - o June 29 feature bus at the parade
  - o Aug 2 kick off service at Starr Hill Brewery with special label
  - o Aug 5 at Old Trail, party, merchants (perhaps coffee)

#### Rivanna Water and Sewer Authority:

- Bill Mawyer, Jennifer Whitaker, Dave Wingate; third year in a row
- Rivanna, formed in 1970, as wholesaler of drinking and waste water
- Operates four drinking systems in Albemarle County
  - o Urban
  - o Crozet
  - o Scottsville
  - o Red Hill
- Rivanna Drinking Water Systems
  - o Crozet uses between 500-800K gal/day
  - o Water from Beaver Creek Reservoir
  - o Projects in Crozet
- Water Supply Reservoirs (five)
  - o Store 3.3bil gal of storage
  - o 500 mil gal in Beaver Creek Reservoir
- Water Treatment Plant (six)
  - o South Rivanna, Observatory, North Rivanna, Crozet, Scottsville, Red Hill
  - o Crozet
- Wastewater Treatment Plants (four)
  - o Moore's Creek, Scottsville, Glenmore, Stone Robinson Elementary

- Reduction of wastewater odor (Route 250)
    - Vendor to monitor odor
    - Volvo dealer area
  - Crozet to Moore's Creek with urban areas; 11mil gal day
- Cost benchmarks (dollars per thousand gallons) question; the Service Authority can best answer
- How ensure high quality and cost effective system
  - Quality
    - Take 150 samples/month in water system
    - Hundreds of samples in plants
    - Report results to the state; subject to state and federal regulations
  - Cost effectiveness – budget review every year with Board of Director
    - Cost based upon age
    - Essentially a middle-aged systems
    - RWSA is 65% of the Service Authority budget
- Crozet Projects (infrastructure outside the plants)
  - Drinking Water Infrastructure Plan
    - Water production rising; ensure capital infrastructure in pipeline to react quickly
    - Projected water demand study
    - Beaver Creek adequate for Crozet out to 2075
    - Double size of water treatment plant
    - Define Crozet area through Crozet Master Plan; in jurisdictional boundary and project size; map from study, approved by AC BoS.
  - Finished Water Pump Station
    - Original built in 60's
    - Fully redundant; handle max day and expandable; expect past 2075
  - Wastewater Equalization Facility
    - Proposed near Fair Hill Estates
    - Location where all Crozet wastewater gathers; storage tank; peak flows into tank, when recedes put into system
  - Lickinghole Stormwater Basin
    - Concrete Dam
    - Dredge lake intentionally; increase bathymetry rate (understand decay rates better)
    - Resident significant erosion; creek moved 50 feet onto his property; who is responsible for erosion downstream; Albemarle County responsible for erosion and sediment control
  - Beaver Creek Dam and Pump Station
    - Visible project near term
    - Joint project NRCS and Albemarle County
    - Earth Dam
    - Covers only ½ of (capacity) Prob Max Flood/Participation
    - Reclassify as High Hazard Dam (people live downstream); cannot currently handle PMF

- Upgrade spillway; labyrinth (zig zag) in middle; move pump station ashore also
  - Build 2023-2026; Brown's Gap Turnpike closure; need to build bridge
  - VDOT and Dam timing for road closure; work for grant funding with gov't
- Granular Activated Carbon Filters
  - Community decided; decision made by all boards; addresses pharmaceutical concerns
  - Bit more expensive
  - Disinfection biological control
  - GAC Results (Haloacetic acids, Trihalomethanes levels)
  - Use bleach solution to disinfect
  - Red in water (ACSA) mold comes from mulch
  - We have high quality water; even compared to other areas of VA
  - PFAS (in water everywhere, common) removed best by GAC; no trace in our water; additional drinking water filtration not needed
- Security Issue question
  - Congressional mandate in 2018 to conduct vulnerability assessment
    - Bio terrorism
    - Natural disaster
    - Rivanna needs to certify by March 2020; monitor by EPA
- Water Treatment Facility Upgrade
  - Complete Dec 2022
  - Cost \$8.5 M
- Bucks Elbow Tank Chlorination System
  - End of system
  - Design to have additional capacity for chlorination
  - Basin addition, improvements
- RWSA has \$200M in debt; finance all infrastructure projects by design; all revenue from selling water to Service Authority
- Lead pipes not in Service Authority system; does ACSA test for lead in households?; corrosion inhibitor product into our water (protect against events like Flint, MI); inhibits leaking of lead into water (polyphosphate product)
- Virginia Tech program (Cooperative Extension) water program for household; water treatment in house next spring

### Barnes Lumber Redevelopment Opportunity:

- Frank Stoner (Milestone Partners) intro, Barnes Lumber Redevelopment Opportunity
- Where we've been
  - o Start in 2014
  - o 50+ Public Engagements since then
- 2017 Downtown Crozet design Town Center and Plaza; 6.25 acres; rezone all of site; what can all folks agree with; voices from community
- Plaza Design (conceptual); MRA and Warren Bird collaboration
- Commercial aspects are challenging; year of meetings
- Agreement before the Board, County next Wednesday
- Project Patriot – Expanding Downtown Crozet
  - o Consistent with Comp Plan, CMP
  - o Consistent with Project ENABLE (private investment for public good)
  - o Phase I – PP Partnership (Road system, Public Plaza); consistency; what is Crozet; helps design process
  - o Phase II, III (rest of project) – people want gridded network, fewer parking lots; secondary road; pedestrian and bike friendly; connect to surrounding neighborhoods
- PPP Project Elements
  - o Predevelopment
  - o Road
  - o Plaza
  - o Financing
  - o Development
- Phase I rezoning to BoS in Aug?
  - o Private Developer Role
    - Architectural guidelines for review; create plaza site plan; environmental issues; rezoning; parking issues (structured, shared); update CMP; county lead public engagement;
    - Development Agreement Summary (Syn-TIF to developer loan)
    - Road
      - Urban Collector Road (reduces parking)
      - Roundabout
      - Downtown needs to be pedestrian friendly
      - Urban shopping district
      - Render area as attractive; timing off
      - Start construction next spring
  - o Public County Role
    - Market Study
    - Parking
    - CMP

### Downtown Crozet Initiative (DCI):

- Next Wednesday at 1 PM BoS; give DCI the project; number 11 on agenda
- Mary Beth Bowen – goal represent Crozet

- Two meetings in May – abt 40 attended; concepts
  - o Crozet now; themes: active socially (volunteerism) and physically; preserve; Mayberry (everyone knows your name...); Cheers theme song...; physical connections – roads, trails, ...; beauty; arts woven into downtown; wineries, breweries in area
  - o Crozet – what do we want it to be; vibrant, outside, community
  - o Keep focus on downtown Crozet

Items Not on the Agenda (Residents Opposing possible construction of Catholic Church on St. George Ave):

- Danny Weissong; St. George Avenue represent community as spokesperson
- Comments:
  - o oldest homes in Crozet; possible home for Catholic Church testimony; zoned residential, flooding issues
  - o Contrary to CMP historic district; increase traffic and pedestrian risk; Anderson Funeral Home site;
  - o Discussion with Catholic community
  - o Strongly opposed to location; believe Church should look elsewhere; threatens historic neighborhood
  - o Petition in circulation
  - o AC Planner – no application for church project has been submitted.
